Your student will receive a state-owned MLTI Mac Book Air. This laptop will enhance your student's learning, as technology is integrated into classroom instruction. The laptop is provided to help students learn "hard to teach" concepts and practice skills needed for academic success. It provides the most current research and information and helps your child learn 21st century skills. Your child may bring the Mac Book Air home to continue work on class assignments, complete homework, and work on projects.

MSAD 75 offers Take Home Coverage for the MLTI Mac Book Air. You may elect to purchase this Take Home Coverage for the laptop assigned to your child. For a one-time yearly fee, the Take Home Coverage covers accidental damage that occurs outside of school. Please see the back of this sheet for the cost of the coverage.

Please note: Wanton and willful destruction or negligence is not covered. Food, drinks, and liquids must not be near the laptop. Damage from food, drink or liquids will be considered negligence. All damage incidents deemed negligence result in students being billed the entire repair charge, or the cost of laptop replacement, if less expensive. The current MacBook Air replacement cost is \$699.00.

Take Home Coverage has limitations. Issues of theft, loss or intentional damage will be referred to administrators and possibly the police for investigation. In these instances the level of coverage will be determined on a case-by-case basis.

MLTI Take Home Coverage can be paid online, in the 'Payment' section of the Infinite Campus Parent Portal. You can also send a payment to school with your child, but we urge you to use the online payment. Payments delivered to school should be turned in to the Main Office. Checks should be made out to MSAD 75.

Laptops will be deployed to eighth graders on Monday, Sept. 14, 2015 and seventh graders on Monday, Sept. 28, 2015. To ensure that your student receives a laptop on that day, each student must:

- 1. Return this completed form indicating whether electing to purchase, or declining coverage.
- 2. Pay any outstanding fees or fines, or make arrangements for a payment plan. (All payment plans must be arranged with school administration.)

Students and parents should complete these steps before 2 PM on their assigned take home date will NOT be allowed to their laptop home. Any outstanding form or fee issues remaining at the start of 2015-2016 school-year will delay the issuing of a laptop to a student.

Please Note: Payment for the coverage can be made when you submit this form, but is not due until October 2, 2015. Any coverage payments not received by October 2, 2015 will result in a cancellation of coverage.

Strategies That Work A Guide for Families to Keep at Home

Discussion with our children about appropriate, safe online and cell phone behavior can help them learn how to use technology wisely. We encourage families to create a family plan about laptop use at home. We suggest you and your child make the plan together. Below are some ideas to consider as you make your family plan:

Internet Use

- > Discuss what internet sites are acceptable to you and may be used at home. Also establish what is not acceptable.
- Talk about the importance of using communication tools in safe, appropriate ways.

Establish Limits

- Establish a time the MLTI laptop will be turned off. Expect and enforce the agreed upon time.
- Communicate where the laptop will be kept each night when it is turned off and being charged. Would having the laptop charging in the kitchen be better than charging in the student's bedroom?

Encourage Balance

- > Get your student involved in offline activities.
- Establish limits on how much recreational screen time will be allowed at home. The American Pediatric Association recommends a two hour daily limit.

Establish a Weekly Physical Check-In Time

- Students are responsible for the laptop. If they damage it, lose it, or choose not o keep it clean the school will hold them responsible. A minimum consequence of fees will be charged.
- > Set up a weekly time to inspect the laptop, charger, power cord and case to be sure it is clean and work properly.
- Encourage students to use the cleaning supplies in the Learning Commons if needed.
- If you and your child find damage to the laptop your child should report the damage to the Learning Commons immediately.

Impart Your Values

- Cheating, lying, being cruel is wrong both offline on online.
- Discuss what is right and wrong in your family and how that relates to online behavior too.

Explain What's at Stake

- Inform your student what they do online today can be abused by someone tomorrow. Help them understand they should "think before they click."
- If your student breaks the family rules you set up about laptop use at home, discuss it. Set consequences with your student and enforce the agreed upon consequences.
